ACCESSIBILITY ASSISTANCE

- Curb-to-curb or door-to-door assistance is available upon request.
- Drivers may assist from the main entrance of a pick-up location to the main entrance of the destination.
- Drivers cannot assist when more than one step (i.e., curb) must be navigated.
- Clients of the Department of Job and Family Services may qualify for medical transportation.

Buckeye Southeast Transit will make reasonable modifications to policies, practices and procedures when necessary to ensure access to transit services for qualified individuals with disabilities, unless:

- Making the accommodation would fundamentally alter the nature of the public transportation service.
- Making the accommodation would create a direct threat to the health or safety of other passengers.
- The individual with a disability is able to fully use Buckeye Southeast Transit's service without the accommodation being made.

Buckeye Southeast Transit operates a demand response, curb-to-curb service Monday through Friday, from 8 a.m. to 5 p.m.

Services are available throughout Morgan, Noble and Monroe counties, with limited availability for rides outside the service area.

All services are open to the public and transit passes are available for purchase at our office.



RESERVATIONS AND SCHEDULING

To schedule or change a ride, call the transit office at 740-962-9125. Please reserve at least 48 hours in advance for all rides. Same-day requests are subject to availability.

- Cancel at least two hours in advance to avoid a no-show fee.
- The "on-time window" allows drivers to arrive 15 minutes before or after the scheduled pick-up time.
- Timing may vary due to traffic or weather.
- Exact cash fare is required; drivers cannot make change.
- Personal care attendants (PCAs) ride free; limit one per passenger. Please inform the dispatcher when scheduling.
- No-shows are charged the full fare.
- First no-show: verbal warning
- Second no-show: written warning
- Three no-shows within 30 days (with unpaid fares) may result in suspension of service.
