Sealed bids will be received by the **MORGAN COUNTY BOARD OF COMMISSIONERS, 155 E. Main St., Room 216, McConnelsville OH 43756** at its offices until **10:00 A.M. on MONDAY JUNE 29<sup>th</sup>, 2026** and will be publicly opened and read immediately thereafter for the:

**“VILLAGE OF MCCONNELSVILLE - EMERGENCY SANITARY SEWER IMPROVEMENTS – PHASE I”**

The Project work shall consist of furnishing all labor, materials, and equipment in accordance with the contract documents. Project cost estimate is \$4,100,000.00.

**All Bidders must register** with the issuing office prior to the Bid Opening by submitting full payment of the non-refundable **registration fee of \$25**. Full physical sets of complete bid documents are also available for an additional fee. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

Federal Prevailing Wage Rates and Equal Employment Opportunity requirements are applicable to this project.

This procurement is subject to the EPA policy of encouraging the participation of small business in rural areas (SBRAs).

Each bid shall be accompanied by a Bid Guaranty and Contract Bond as required by Section 153.54 of the Ohio Revised Code in an amount equal to the sum of the bid submitted by each contractor. In lieu of posting the bond, a bidder may use a Cashier's Check, Certified Check or Letter of Credit for ten percent of the Contractor's bid as bid security. When a check or letter of credit is used, the bidder shall be required to post a 100 percent Performance Bond and a 100 percent Labor and Material Payment Bond, upon the signing of the contract.

Failure to submit the Bid Guaranty Bond and the required notarized affidavits with the bid shall be cause for considering the bid submission incomplete and for the rejection of the bid. Each bid must contain the full name of the party or parties submitting the bid and all persons interested therein. Each bidder must submit evidence of its experiences on projects of similar size and complexity. All contractors and subcontractors involved with the project will, to the extent practicable use Ohio Products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123.2, the Governors Executive Order of 1/27/72, and Governor's Executive Order 84-9 shall be required. The provisions of the Ohio Administrative Code (OAC) 123:2-3-02 through 124:2-9 regarding Equal Employment Opportunity on State Construction Contracts and State-assisted Construction Contracts, and OAC 123:2-3-02 through 123:2-9 regarding Equal Employment Opportunity and Female Utilization Goals are applicable to this project, and each contractor will be required to comply in all aspects of these provisions. The proposed work is subject to the requirements of Section 3 of the Housing and Urban Development Act of 1968 and the implementing regulations at 24 CFR part 75. The criteria for determining eligibility as a Section 3 business concern can be found in 24 CFR 75.5 and the selected Contractor's Section 3 obligations, as described at 24 CFR 75.19.
